



ROUNDTABLE "MAKING NEW JUSTICE INSTITUTIONS RESILIENT"

Once set up, the SEE6 institutions must function efficiently and produce qualitative and efficient outputs without permanent relying on external assistance. To be sustainable new structures must be well governed. To be resilient they should plan in long term, take into account the availability of local resources, and carry regularly risk-management exercises. Good governance features of effectiveness, efficiency, transparency, accountability, predictability, sound financial management and integrity compliance should characterize the new institutions.

In the case of Justice Reform, good governance of new institutions implies getting the right <u>organogram and</u> <u>Rules of Procedure</u>, the <u>human resources</u>, the <u>appropriate budget</u>, the <u>logistics</u> including physical space, and <u>systems and tools</u> in place. It involves making sure that responsibility and tasks are clearly assigned, and that staff are motivated and have the competences required carrying their duties with highest degree of integrity and professionalism.

The round table will aim to take stock of the current situation of new Justice reforms structures, by identifying good governance challenges that impact their throughput legitimacy and resilience. We will use the 'Appreciative Inquiry' approach to identify and assess features of the selected new structures and institutions belonging to the <u>positive core of justice sector reform</u>, such as vision, values, embedded knowledge, learning processes, organizational achievements, availability of technical and financial resources, efficacy, accountability, transparency, openness, inclusiveness, and integrity.
